### The Startling Facts

Today, there are over 29 million people nationwide living with diabetes, and 8 million don't even know it! And 89 million Americans have prediabetes. Diabetes is the seventh-deadliest disease in the United States, killing more people than AIDS and breast cancer combined. It strikes 26% of Americans over age 65 and costs more than \$174 billion annually in health care and lost productivity.

### The Disease

People with diabetes do not produce or respond properly to insulin, a hormone needed for daily life. Diabetes affects the way the body uses food and causes elevated blood sugar levels. Over time, the heart, blood vessels, kidneys, eyes and nerves can be severely damaged, causing heart disease, blindness, kidney failure and amputations.
