V Values: Leadership is about creating values. Values that reflect who you are and what you stand for. Values that will take our organization moving forward and keep it together for years to come.

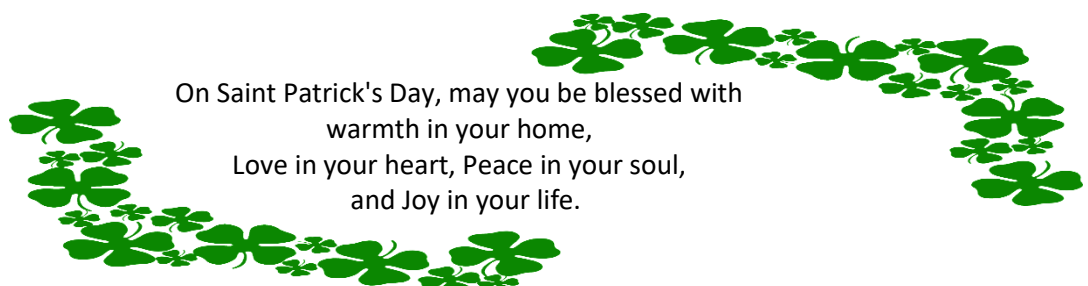
A MESSAGE FROM SK JIM – Grand Royal Patron

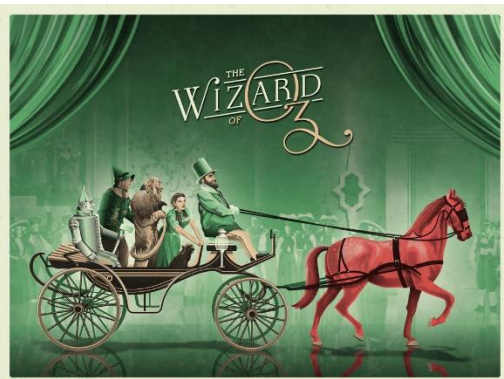
